## **About the Study**

NLTS 2012 is a national study of young adults' experiences during and after high school. NLTS 2012 collects information from young people, their schools, and other sources. This information paints a picture of what happens with this group across the country, whether it includes involvement with jobs, training programs, schools/colleges, or other experiences as adults.

## Why NLTS 2012 is Important

NLTS 2012 is a key source of information that can provide a national picture of the experiences and achievements of youth. The results will be used by policymakers at the local, state, and national level to improve how students are taught and how they learn in the United States, to help our youth be successful in adult life.
