## **TITLE OF INFORMATION COLLECTION:**

U.S. - China Race to Zero Emissions (R2ZE) Challenge Volunteer Registration for Transit Agencies with Zero Emission Buses

## **PURPOSE:**

This information collection encompasses the name, address, point of contact, work phone, work email address, transit logo, website address, and number/percentage of zero emissions buses (ZEBs) in transit fleet who want to voluntarily join the R2ZE Challenge. This information will be used to set a baseline for ZEBs in a transit agency fleet, which will then be used to calculate the percentage increase of ZEBs in their fleet on an annual basis. The collection also provides for the option to receive emails about the program.

The R2ZE Challenge is an initiative under the U.S. – China Climate Change Working Group that encourages bus transit agencies in the U.S. and China to deploy innovative, advanced, non-polluting ZEBs in their systems.

## **DESCRIPTION OF RESPONDENTS:**

Potential respondents are transit agencies in the United States with bus fleets which have partially or fully deployed ZEBs in their systems and voluntarily submit their information to take part in the R2ZE Challenge.
