

**2015 Summer Mail Messaging Test- Minimal Design Treatment, Softened Design Treatment, and Design Treatment**

The following table outlines how the current messaging in the newly designed materials is being modified for the Summer Mail Messaging Test – Minimal Design Treatment, Softened Design Treatment and Design Treatment. The first and second columns list the form name and the ACS production form number that it is replacing.
