Further, the Applicant, if selected as a Participant, hereby agrees to contractually commit to make specifically enrolled vessels or capacity available for use by the Department of Defense and to other Participants as described in this Agreement.

By signing this Agreement, Participants agree to commit their vessels for a period beginning with the effective date below through the period for an entire fiscal year (October 1 through September 30). VTA vessel enrollment will automatically renew for each subsequent fiscal year unless the Participant provides written notification to the Maritime Administration of its intent to terminate participation in the VTA and Maritime Administration approval is granted.
