SUBJECT: Non-Substantive Change – Merge hours from Local School Wellness Policy ICR OMB Control Number 0584-0592 to OMB Control Number 0584-0006 Part 210 -National School Lunch Program, Discontinue OMB Control Number 0584-0592, and Remove FNS-640 and its Associated Reporting Burden from OMB Control Number 0584-0006

The information collection (ICR) burden associated with the recently published Final Rule titled "Local School Wellness Policy Implementation under the Healthy, Hunger-Free Kids Act of 2010" is currently approved under OMB Control #0584-0592, which expires 9/30/2019. As part of this approval, FNS stated that this burden would be merged into OMB Control #0584-0006, "Part 210-National School Lunch Program", with an expiration date of 9/30/2019.

In addition, FNS requested approval from OMB to transfer FNS-640 Administrative Review Report and its associated reporting burden (currently approved under OMB Control #0584-0006), into OMB Control #0584-0594 Food Programs Reporting System (FPRS) (with an expiration date of 9/30/2019), to facilitate the accurate and timely electronic collection of this data. OMB approved this request on 10/07/2016.

At this time, FNS is requesting a no material/non-substantive change to merge the burden assigned to OMB Control #0584-0592 into and to remove FNS-640 and its associated reporting burden from OMB Control #0584-0006. The current burden for OMB #0584-0592 is 156,923 hours and 66,073 responses, while the reporting burden for FNS-640 is 140 hours and 56 responses. These two changes result in an overall

burden increase of 156,782 burden hours and 66,017 responses for OMB #0584-006. The merge will also discontinue OMB #0584-0592. The new burden for OMB #0584-0006 is as follows:

<sup>\*</sup>Please note that part of the total burden for OMB # 0584-0592 includes 4,955.5 recordkeeping burden hours which were rounded to 4,956. So while subtracting the 140 hours for FNS-640 from the 156,923 hours for OMB #0584-0592 provides an increase of 156,783 hours, the rounding results in the overall increase of 156,782 hours as shown in table above and described in the text.
