The U.S. Census Bureau has selected your business to participate in the **2016 Annual Capital Expenditures Survey (ACES)**. Your response is required by law. Title 13, United States Code, Sections 131 and 182 authorizes this collection. Sections 224 and 225 require your participation. Section 9 of Title 13 requires that the Census Bureau keep this report **strictly confidential**. Your information is only used to develop summary statistics that do not reveal the individual activities of your business. Under the same law, information cannot be used for taxation, regulation, or investigation and is exempt from release under the Freedom of Information Act. We estimate this survey will take between 2 to 16 hours to complete with an average of 2.57 hours. You may use reasonable estimates if book figures are not readily available.
