Protocol and Questions for Unmoderated User Testing of a Proposed New CMS.gov Website Structure

Pre-Test Questions

Participants will be asked to respond to the following two questions when they first land on the testing web page:

How often do you visit CMS.gov? (select one)

- O Multiple times a day
- 0 Multiple times a week
- o A few times each month
- O A few times each year

Which of the following best describes your role? (select one)

- O Health Care Providers (Clinicians/Physicians)
- O Health Care Providers (Practice Administrators)
- O Health Care Providers (Consultants)
- O Health Care Providers (Coders and Billers)
- O Health Insurance Brokers/Agents
- O Health Insurance Assisters/Counselors
- o Other [please describe]

Site Structure Tree Testing

We will enter the new site structure (the names of each page in a hierarchical arrangement) into an unmoderated testing platform called Treejack (from a company called Optimal Workshop). Treejack automatically makes our hierarchical site structure navigable online. That is, participants will be able to click on each node of the site structure in succession in order to find specific pages.

We will ask participants to complete the following seven tasks, which are common reasons that people visit the CMS.gov website:

- O Look up a specific National or Local Coverage Determination
- O Find a physician fee schedule
- Download a spreadsheet of Medically Unlikely Edits (MUEs)
- O Get resources that would enable you to provide guidance to a beneficiary who is looking to purchase private insurance
- O Learn about the Nursing Home Quality Initiative
- O Review drug pricing for Medicare Part B
- O Get training

For each task, participants navigate the clickable site hierarchy in the Treejack tool in order to find the page on which they believe they can complete the task. Each task is expected to take 2-3 minutes.

Here are the tree testing instructions that will appear to participants

Instructions

Here's how it works:

- 1. You will be asked to find a certain item and presented with a list of links.
- 2. Click through the list until you arrive at one that you think helps you complete the task.
- 3. If you take a wrong turn, you can go back by clicking one of the links above.







This is not a test of your ability, there are no right or wrong answers.
