

# Ethanol Flex Fuel (EFF) Bulk Blender-Refiner Aggregate Report (EFF0300): Instructions for Completing

# Who must report

• Any EFF bulk blender-refiner for each of its bulk blender-refineries shall submit to EPA an Ethanol Flex Fuel Bulk Blender-Refiner Aggregate Report. This report is used to demonstrate annual compliance with applicable EFF requirements.

# **Reporting deadlines for refiners and importers**

• EFF bulk blender-refiners shall submit to EPA the Ethanol Flex Fuel Bulk Blender-Refiner Aggregate Report by March 31<sup>st</sup> of each year for the prior calendar year averaging period.
