Your facility has been approved to be listed in the Behavioral Health Treatment Services Locator maintained by the Substance Abuse and Mental Health Services Administration (SAMHSA). The newly updated Locator is an online directory that contains listings for both substance abuse treatment facilities and mental health treatment facilities, and can be found at <a href="https://findtreatment.samhsa.gov">https://findtreatment.samhsa.gov</a>. SAMHSA maintains the Locator as a public service for persons seeking treatment for themselves or family members. There is no charge for being listed on the Locator.

To be listed in the Locator, a mental health treatment facility must respond to SAMHSA's annual survey of mental health treatment facilities called the National Mental Health Services Survey (N-MHSS).

Although data collection for the next N-MHSS is not scheduled to begin until March 2018, facilities that are approved in the interim can be quickly added to the Locator by answering a brief set of questions about the types of treatment and services they offer.
