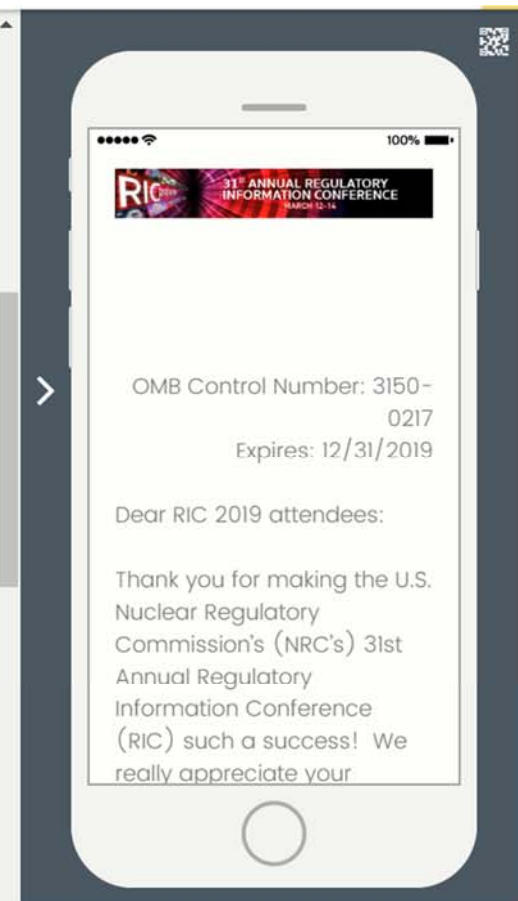

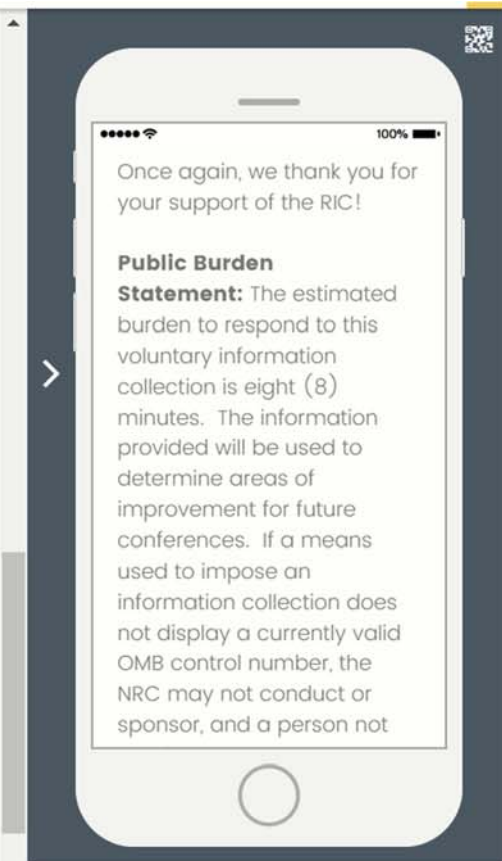

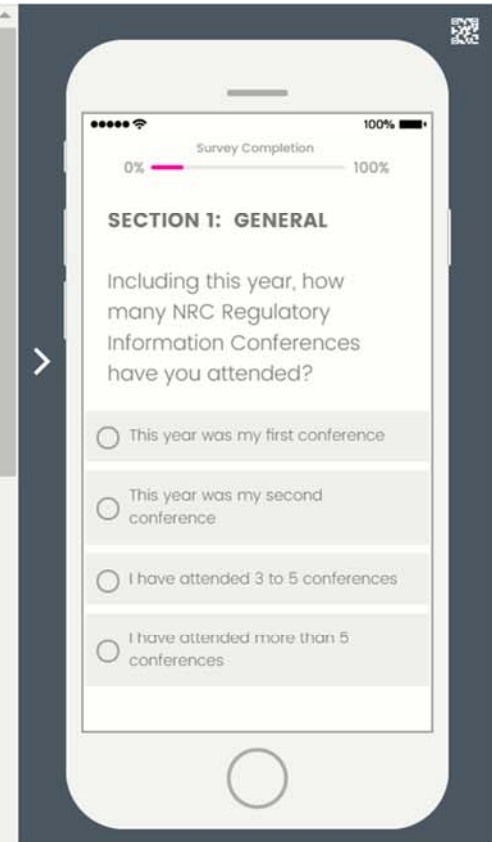

Which **best** describes your employment affiliation?

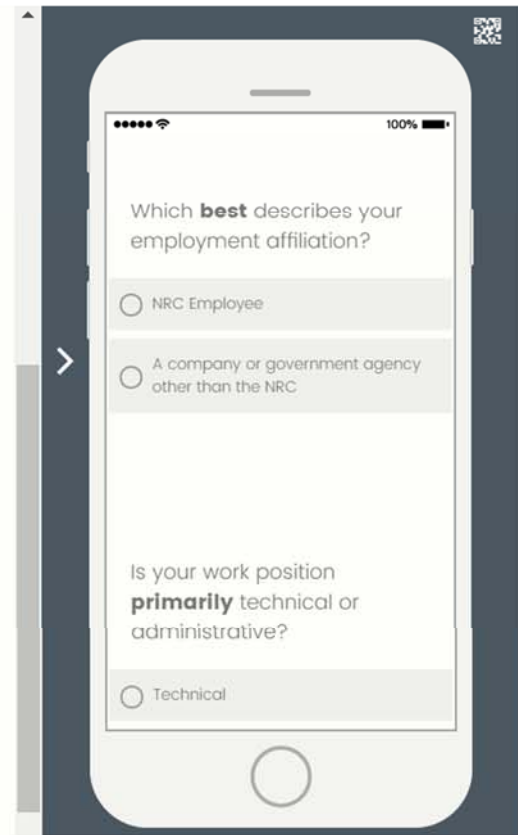
