As requested, DMDC has reviewed the subject study protocol and it's

supporting materials as part of the OMB and RCS submission process through WHS/ICB. The concerns raised in our review have been adequately addressed. Our recommendation to WHS/ICB is that the information collection materials are sufficiently designed and developed in order to be sent forward as required to obtain OMB clearance for a Public Information Collection. Further, we recommend that the information collection be approved and licensed under DoDI 1100.13 and DoDI 8910.01, respectively.
