To identify, quantify and evaluate recreation use and expenditures for planning, feasibility studies, environmental assessments, environmental impact statements, development of visitation models, and estimates of economic benefits for both existing water resource projects and proposed water resource development. Members of the public including individuals and groups, who have visited, are visiting, or plan to visit U.S. Army Corps of Engineers Water Resource Projects for the purpose of recreation activities are interviewed as they exit the recreation area. Data is captured directly on a government computer. E-mail address is requested for the purposes of sending a follow-up survey regarding their use and expenditures. Participation in the interview and the follow-up survey is voluntary.

(2) Briefly describe the privacy risks associated with the PII collected and how these risks are addressed to safeguard privacy.

Demographic information captured in addition to e-mail address includes gender, age range, race, ethnicity, and income range. E-mail address used for the purposes of the follow-up economic survey and is scrubbed from all records following the data collection effort during the data review and cleaning process. The remaining information in the electronic record that is stored contains no PII. Unique survey ID and identifying numbers related to the survey location are the only way to pull specific records.
