**General Instructions**

**Specific Instructions**

**A. Justification**

***1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.***

Section 8(k) of the Outer Continental Shelf (OCS) Lands Act, as amended (43 U.S.C. 1337), authorizes the Secretary of the Interior (Secretary) to grant to the qualified persons, offering the highest cash bonuses on a basis of competitive bidding, leases of any mineral other than oil, gas, and sulphur in any area of the OCS not then under lease and prescribe royalty, rental, and other terms and conditions for such minerals. The Secretary administers the leasing provisions of the Act and prescribes the rules and regulations necessary to carry out those provisions.

This authority and responsibility are among those delegated to the Bureau of Ocean Energy Management (BOEM). The regulations at 30 CFR 581 concern leasing activities for minerals other than oil, gas, or sulphur and are the subject of this collection. There has been no leasing activity for these minerals in the OCS for many years and no information collected. However, because these are regulatory requirements, the potential exists for information to be collected; therefore, we are requesting a renewal of this information collection.

***2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection. [Be specific. BOEM uses the information required by 30 CFR 581 to determine if statutory requirements are met prior to the issuance of a lease. Specifically, BOEM would use the information to:

- Evaluate the area and minerals requested by the lessee to assess the viability of offering leases for sale.
- Evaluate the mineral(s) deposits requested by the lessee to ensure that the Federal Government receives fair market value for the mineral(s).
- Request the State(s) to initiate the establishment of a joint working group or task force to assess the proposed action and provide input.
- Ensure excessive overriding royalty interests are not created that would put economic constraints on all parties involved.
- Document that a leasehold or geographical subdivision has been surrendered by the record title holder.
- Determine if activities on the proposed lease area(s) will have a significant impact on the environment.

**3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden and specifically how this collection meets GPEA requirements.**

Although there are no current respondents for this collection, we expect that a respondent would submit 100% of the required information electronically.

**4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

There is no duplication. The Department of the Interior has specific statutory authority. No other Federal agency collects this information because it pertains to a specific OCS lease for minerals other than oil, gas, and sulphur. To the extent that identical information or data were available from prior submissions, BOEM would not require respondents to resubmit such information or data.

**5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.**

This collection of information could have a significant economic effect on a small number of small entities. Any direct effects primarily impact the OCS lessees and operators. Many of the OCS lessees and mining companies may have less than 500 employees and would be considered small businesses as defined by the Small Business Administration. Regulations require safe work practices and protection of the environmental resources; therefore, the hour burden on any small entity subject to these regulations and associated collection of information cannot be reduced to accommodate them.

**6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.**

If we did not collect the information, BOEM could not carry out the mandate of the OCS Lands Act. Respondents generally submit reports as a result of situations encountered and not at any fixed or prescribed interval.

**7. Explain any special circumstances that would cause an information collection to be conducted in a manner:**

**(a) requiring respondents to report information to the agency more often than quarterly;**

Not applicable in this collection.

Not applicable in this collection.

This collection does not require proprietary, trade secret, or other confidential information not protected by agency procedures.

As required in 5 CFR 1320.8(d), BOEM provided a 60-day notice in the *Federal Register* on April 14, 2017 (82 FR 18008). We received no comments in response to the *Federal Register* notice. The Paperwork Reduction Act explains that agencies will accept comments at any time on the information collected and the burden. We display the OMB control number and provide the address for sending comments to BOEM.

There are currently no competitive leasing activities for minerals other than oil, gas, and sulphur in the OCS, and none are planned in the near future. Therefore, there are no companies to contact for updated information.

***9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.***

BOEM will not provide payment or gifts to respondents in this collection.

***10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.***

We protect proprietary information according to the Freedom of Information Act (5 U.S.C. 552) and the Department's implementing regulations (43 CFR 2, and 30 CFR parts 580 and 582).

The collection does not include sensitive or private questions.

As there are no active respondents, we are estimating an average of one respondent per year. Respondents are lease requestors, State governments, and OCS lessees. The burden estimates include the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. Submissions are generally on occasion and are mandatory or required to obtain a benefit. We estimate the total annual burden is 984 hours. Refer to the following table for a breakdown of the burdens.

We estimate the total annual burden is 984 reporting and recordkeeping hours. Based on a cost factor of \$93 per hour, we estimate the hour burden as a dollar equivalent is \$91,512 (\$93 x 984 hours = \$91,512).

**13. Provide an estimate of the total annual non-hour cost burden to respondents or recordkeepers resulting from the collection of information. (Do not include the cost of any hour burden already reflected in Item 12).**

**(a) The cost estimate should be split into two components: (1) a total capital and start-up cost component (annualized over its expected useful life) and (2) a total operation and maintenance and purchase of services component. The estimates should take into account costs associated with generating, maintaining, and disclosing or providing the information (including filing fees paid for form processing). Include descriptions of methods used to estimate major cost factors including system and technology acquisition, expected useful life of capital equipment, the discount rate(s), and the time period over which costs will be incurred. Pursuant to § 581.41, respondents would pay a \$50 application fee for approval of any instrument required to be filed, or for any non-required filing as well (see burden table in section A.12). We have identified no other non-hour cost burdens for this collection of information.

**14. Provide estimates of annualized cost to the Federal Government. Also, provide a description of the method used to estimate cost, which should include quantification of hours, operational expenses (such as equipment, overhead, printing, and support staff), and any other expense that would not have been incurred without this collection of information.**

The average cost to the Federal government is \$78/hour. This cost is broken out in the below table using the 2017 Office of Personnel Management pay schedule for the Washington, DC metro area.

To analyze and review the information, the Government spends an average of ½ hour for each hour spent by respondents. The total estimated Government time is 492 hours. Based on a cost factor of \$78 per hour, the total annual estimated burden on the Government is \$38,376 (984 hours x ½ hour = 492 hours x \$78 = \$38,376).

**15. Explain the reasons for any program changes or adjustments in hour or cost burden.**

The current OMB inventory includes 1,264 annual burden hours for the collection of information in 30 CFR 581. This submission is requesting a decrease of 280 hours from those burden hours. Due to solicitor review, burdens from two provisions in subpart B—Leasing Procedures were removed because the information is exempt as defined in 5 CFR 1320.3(h)(4). These provisions are:

- 30 CFR 581.12, submit response to Call for Information and Interest on areas for leasing of minerals in accordance with approved lease program (120 annual burden hours); and
- 30 CFR 581.16, submit suggestions and relevant information in response to request for comments on the proposed leasing notice (160 annual burden hours).

The current OMB non-hour cost burden inventory is \$50 for respondents to file a required and/or non-required document under § 581.41 and remains the same.

BOEM will not tabulate or publish the data.
