10b. In order to generate random numbers, follow steps i-v below.

- In the “Max” field enter the (question 6) number of sites in this [State].
- Press the “Generate” button to produce a single random number.
- Record the random number that is displayed in the “Random Number Generated” column of the table in (question 12) below.
- Repeat steps ii and iii until (question 9) sites are chosen.
- If a randomly-generated number is the same as a previously-generated number, discard that number, it will not count towards reaching the number of (question 9) sites. Be sure to replace this discarded number with a valid number using steps ii and iii.

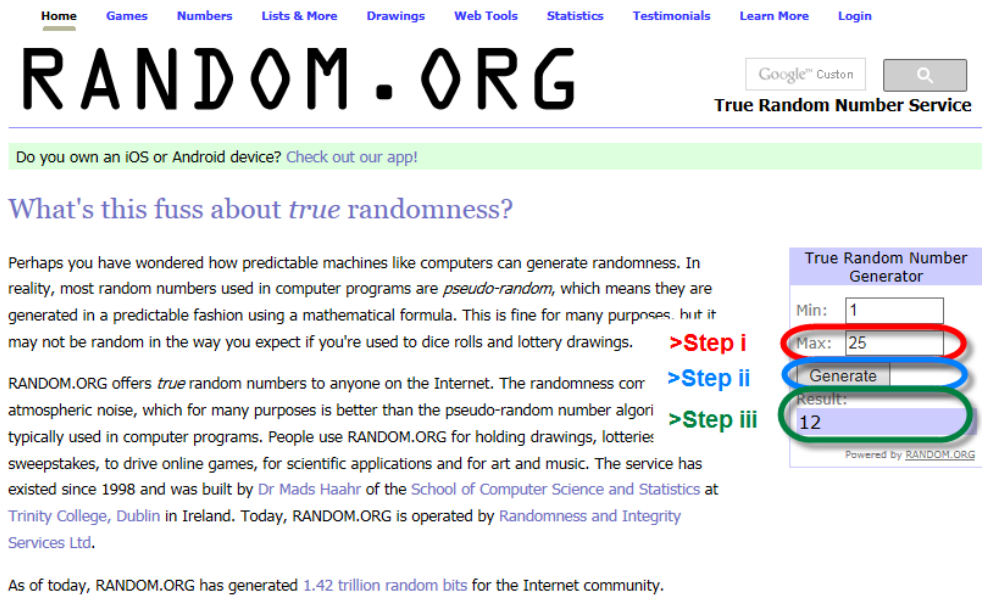


Figure 1: Illustration of [www.Random.Org](http://www.Random.Org) web site. The portions of the random number generator used in steps i-iii of (question 10b) are circled.

**Choosing random numbers using a random number table (use if no internet connection is available)**

- 11a. See Figure 2 for a random number table that will be used to select a random number of sites.
- 11b. To choose random numbers from the table, perform steps i-iv below.
- i. Write the day of your own birthday (e.g., if your birthday is January 10<sup>th</sup>, you would write “10” here). This will determine the starting column: .....
  - ii. Next, you will need to use your birthday column, plus enough columns to the right so that the total number of columns are equal to the number of digits in the total number of (question 6) sites. See below for some examples.

Number of sites from (question 6)	Columns to use
2 to 9	Birthday column only
10 to 99	Birthday column plus ONE column to the right of it
100 to 999	Birthday column plus TWO columns to the right of it
1,000 to 9,999	Birthday column plus THREE columns to the right of it

Write down the column numbers of your birthday column, plus the columns to the right of it that are needed (e.g., if your birthday column is 10, and there are 45 sites, write down “10, 11”):

- iii. **DIRECTIONS:** Start in row 1 and your columns from step ii. If the number in this position is valid (i.e., between 1 and the total number of sites from (question 6)), then write it down in the “Random Number Generated” column of the table in (question 12). If that number is not valid, do not write it down in the table in (question 12). Then, proceed to row 2, row 3, row 4, and so on, and write valid random numbers in the “Random Number Generated” column until the appropriate number of sites (question 9) has been reached

**EXAMPLE:** If we have 45 sites and are looking in columns 10 and 11, we would start in row 1 and write down “25”, then “14” from row 2, then skip “63” and “99” in rows 3 and 4, since 63 and 99 are both above the total number of sites and continue similarly until the number of (question 9) sites are chosen.

**NOTE:** if you reach row 30 and have not met the number of (question 9) sites, continue in row 1, using the next set of columns to the right of the set just used (e.g., if we reached row 30 using columns 10 and 11 and still needed to select more sites, we would start again in row 1 of columns 12 and 13).

- iv. If a randomly-generated number is the same as a previously-generated number, discard that number, it will not count towards reaching the appropriate number of (question 9) sites. Be sure to replace this discarded number with a valid number using step iii.
