1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

Section 154 of the Energy Policy Act of 2005 directs HUD to develop and implement an integrated strategy to reduce utility expenses through cost-effective energy conservation and efficiency measures and design, and construction of public and assisted housing. In support of these requirements, HUD has revised its administrative requirements in Chapter 12, "Energy Conservation" of HUD Handbook 4350.1 REV-2. Additionally, the chapter supports HUD's Energy Strategy as reported to Congress in August 2012 and the Memorandum of Understanding entered into by HUD, The U.S. Environmental Protection Agency, and the U.S. Department of Energy in 2002.
