1. How many unique pediatric patients/clients/clients have you seen? Has the practice seen?
2. How many patients/clients/clients did you screen/were screened for FASD?
3. How many patients/clients/clients screened positive for FASD?
4. How many patients/clients/families were referred for further assessment and/or treatment of FASD?
5. How many unique patients/clients age 9 and older have you seen? Has the practice seen?
6. How many patients/clients did you screen/were screened for alcohol use using validated screening questions/tools?
7. How many patients/clients screened positive for risky alcohol use?
8. How many patients/clients screening positive for risky alcohol use received a brief intervention?
9. How many patients/clients were determined likely to have an alcohol use disorder?
10. How many patients/clients were referred for alcohol use disorder treatment?
11. How many unique, non pregnant female patients/clients age 14 to 44 years old did you see/has the practice seen? (If zero, go to question 12).
 - a. How many of these patients/clients received pregnancy risk assessment?
 - b. How many of these patients/clients were assessed as at risk for pregnancy? (post menarche, sexually active with at least one male partner , not using contraception effectively or at all, and not sterile)
