We are inviting you to participate in a 15-25 minute Health Information Technology (HIT) related survey being conducted by the Substance Abuse and Mental Health Services Administration (SAMHSA) and the Office of the National Coordinator for Health Information Technology (ONC). As you may know, SAMHSA has established Health Information Technology (HIT) as one of its Strategic Initiatives aimed at advancing the use of HIT to support integrated behavioral health care and its potential to transform the health care system. To support this initiative, SAMHSA and ONC have developed a survey instrument that will collect data on behavioral health information technology adoption and use, as well as interoperability among SAMHSA grantees.
