PURPOSE: The purpose of the Exempt Organizations Card Sorting Study is to gather insight on how representatives of tax-exempt organizations organize tax goals and topics. These insights will be used to improve navigation of the “Charities & Non-Profits” section of IRS.gov and ensure the information architecture meets the needs of users.

The study will be conducted in two parts. Part 1 will include a moderated, remote card sort with representatives of tax-exempt organizations as participants. Part 2 will incorporate an unmoderated, remote card sort with different participants of the same demographic. Participation in both parts is voluntary and anonymous, and no personally identifiable information will be collected.
