On behalf of the Licensees, Eagle Creek Renewable Energy hereby submits the kilowatt hours generated throughout the 2016 fiscal year (October 1, 2015-September 30, 2016) in accordance with Title 18, Chapter 1, Subchapter B, Part 11 Code of Federal Regulations.

Attached to this submission, Eagle Creek Renewable Energy lists the twenty-five development projects rated 1.5 megawatts or greater, the FERC project numbers, the Licensee and the kilowatt hours generated during the 2016 fiscal year.

Eagle Creek Renewable Energy purchased Riley, Jay, Livermore and Otis from Verso Maine Power Holdings January 6, 2016. Alice Falls was purchased from Alice Falls Corporation on July 1, 2016. Pepperell and Woronoco purchased from Swift River Hydro Operations Company on July 29, 2016. The kilowatt hours listed for these projects are from the date of purchase through the end of the fiscal year. Alice Falls did not generate at any time within the 2016 fiscal year. And furthermore, Eagle Creek Renewable Energy sold the Hatfield Hydroelectric project to Black River Partners on October 25, 2016.
