SUPPORTING STATEMENT FOR PAPERWORK REDUCTION ACT SUBMISSION UNDER 5 CFR PART 1320 INFORMATION COLLECTION: 2133-0524 APPLICATION FOR CONVEYANCE OF PORT FACILITY PROPERTY

Justification

1. Explain the circumstances that make the collections of information necessary. Include identification of any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

The Secretary of Transportation is authorized to convey surplus Federal property to public agencies provided the property is used and maintained for the development or operation of a port facility. Public Law 103-160, Section 2927, which amends 40 U.S.C. 554 (The Federal Property and Administrative Services Act of 1949) states:

...no transfer of property may be made until the Secretary of Transportation has received ... and approved an economic development plan submitted by an eligible grantee and based on assured use of the property to be conveyed as part of a necessary economic development program ...

This information collection meets two Department of Transportation (DOT) strategic goals: Economic Competitiveness and State of Good Repair. Applicants are also required to submit a non-discrimination assurance statement, as required by DOT Order 1050.2A.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

Information is obtained from any State; i.e., the District of Columbia, the Commonwealth of Puerto Rico, Guam, American Samoa, the Virgin Islands, the Trust Territory of the Pacific Islands, the Commonwealth of the Northern Mariana Islands, or any political subdivision, municipality, or instrumentality thereof. The data obtained from the applicants allows MARAD to approve the conveyance of property and administer the program. Without such data, MARAD is unable to determine whether:

- (1) The applicant is committed to the redevelopment/reuse plan;
- (2) The redevelopment/reuse plan is viable and in the best interest of the public;
- (3) The property will be used in accordance with the terms of the conveyance and applicable statutes and regulations; and
- (4) To determine whether recipients of conveyed property have complied with terms and conditions of the conveyance.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology. Also describe any consideration of using information technology to reduce burden.

The information contained within the application is not solely used by MARAD, as applications are forwarded to cooperating Federal agencies for their concurrent review. Some of the information in the application is generated by engineering-based, non-standard programs such as AutoCAD, SPSS and GIS, which aren't installed on MARAD's computers, but sometimes are on the computers of the cooperating Federal agencies. These agencies may request either an electronic copy of the application or a physical copy of the application from MARAD, depending on their need for such data.

Note: The application goes through an extensive public review process by the Department of Defense (DOD) and/or the General Services Administration (GSA) prior to determining whether the property is suitable for MARAD's public benefit conveyance program. Further, all of the information MARAD requests are compiled by DOD/GSA and the applicant well before MARAD is brought online, so there is no additional burden to the applicant.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in item 2 above.

MARAD has contacted DOD and other Federal agencies to identify if the data needed is presently available. From this search, it was determined that the data being requested from the applicants is unique to this program. There are no duplications.

5. If the collection of information involves small businesses or other small entities (Item 5 of OMB Form 83-I), describe the methods used to minimize burden.

This question is not applicable. Small businesses are not eligible to receive property from the Port Conveyance Program.

6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing the burden.

The impact would be negligible if data were collected less frequently. However, all of the applicants and grantees annually publish the data MARAD requests as a normal part of conducting business. These documents are normally printed in the form of an annual operational report and an annual audited financial statement. Additionally, collecting data on a yearly basis is standard practice among the sponsoring agencies that administer public benefit conveyance programs.

7. Explain any special circumstances that would cause an information collection to be conducted in a manner:

- ➤ Requiring respondents to report information to the agency more often than quarterly;
- ➤ Requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;
- Requiring respondents to submit more than an original and two copies of any document:
- ➤ Requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;
- ➤ In connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;
- Requiring the use of a statistical data classification that has not been reviewed and approved by OMB;
- ➤ That includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing data with other agencies for compatible confidential use; or
- ➤ Requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.

There are no special circumstances that require the collection of information to be conducted in any manner described above.

8. If applicable, provide a copy and identify the date and page number of publication in the <u>Federal Register</u> of the agency's notice required by 5 CFR 1320.8(d), soliciting comments on the information collection prior to submission to OMB. Summarize public comments received in response to that notice and describe actions taken by the agency in response to these comments. Specifically address comments received on cost and hour burden.

MARAD published a 60-day notice and request for comments on this information collection in the Federal Register on January 19, 2017, (FR 6723, Vol. 82, No. 12), indicating comments should be submitted on or before March 20, 2017. No comments were received. In addition, a 30-day notice was published in the Federal Register on April 24, 2017, (FR 18965, Vol. 82, No. 77), indicating comments should be submitted on or before May 24, 2017.

9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

No payments or gifts are provided to respondents.

10. Describe any assurance of confidentiality provided to respondents, and the basis for the assurance in statute, regulation, or agency policy.

Most requested data is not confidential and can be located on the applicant's website. MARAD rarely receives confidential data dealing with business transactions such as leases. MARAD has no intention of releasing business confidential data to the public without first consulting the applicant and following the procedures in the Freedom of Information Act. MARAD has not received any Freedom of Information Act requests relating to the Port Conveyance Program in the last five years.

11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private. This question is not applicable. There are no questions of a sensitive nature.

MARAD requests data from the applicants (estimated to be 13). The agency estimates there will be one application per applicant with requests for amendments to the terms of the original conveyance and subsequent annual reporting requirements.

Approximately 40 hours for each application x 13 applications = 520 hours total response time for all original applicants.

Approximately 2.50 hours for each application x 13 applications = 32.50 hours for amendments.

Approximately 1.50 hours for each application x 13 applications = 19.50 hours for compliance requirements.

Note: The responsive individuals are different based on the entity, but the three most common titles of respondents are as follows with the estimated hourly mean wage:

- Director of Economic Development/Director of Business Development @ \$65.80 per hour
- Manager/Director of Real Estate @ \$63.75 per hour
- Port Director/Chief Executive Officer @ \$110.62 per hour

It is estimated that each respondent would spend 44 hours of their time preparing, amending, and submitting their application. Therefore, given an estimated average hourly wage of \$80.57 for each respondent, the burden cost to the respondent is:

Estimated annual burden cost for respondents is **\$64,520.45**.

13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information. (Do not include the cost of any hour burden shown in items 12 and 14.)

- The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance and purchase of services component. The adjustment in items 13 of the OMB Form 83-I was due to an increase in the number of applications that were received.

There are no plans to publish any of the data collected. The Port Conveyance Program is an ongoing initiative. The filing of an application is required to obtain property, amendments are required as the original redevelopment plan changes and the yearly filing requirements are for compliance reasons. The conveyance is in perpetuity so the amendments and reporting requirements will continue forever unless the requirement is changed by MARAD.

MARAD is not seeking approval to avoid displaying the expiration date for OMB approval in the form.
