PART I.—GENERAL INFORMATION

Background. --This proceeding was instituted in response to a petition filed on July 13, 2017, by the Cast Iron Soil Pipe Institute, Mundelein, IL. Countervailing and antidumping duties may be assessed on the subject imports as a result of these proceedings if the Commission makes an affirmative determination of injury, threat, or material retardation, and if the U.S. Department of Commerce (“Commerce”) makes an affirmative determination of subsidization and/or dumping. Cast iron soil pipe fittings covered by these investigations are finished and unfinished cast iron soil pipe fittings (“CISPF”), regardless of industry or proprietary specifications. These are non-malleable iron castings of various shapes and sizes used in conjunction with cast iron soil pipe in the sanitary and storm drain, waste, and vent piping of buildings. These fittings include various designs and sizes, consisting of bends, tees, wyes, traps, drains, and other common or special fittings, with or without side inlets. C

CISPF are classified into two major types – hub and spigot and hubless. Hubless pipe and fittings are also referred to in the plumbing industry as no-hub. CISPF are distinguished from other types of non-malleable cast iron fittings by the manner in which they are connected to cast iron soil pipe and other fittings. Hubless cast iron soil pipe and fittings are manufactured without a hub, generally in compliance with CISPI 301 and/or ASTM A888. The method of joining the pipe and fittings utilizes a metallic shielded hubless coupling, generally manufactured to CISPI 310 and/or ASTM A 74, that telescopes over the plain ends of the pipe and fittings and is torqued to seal the joint. Hub and spigot pipe and fittings have hubs into which the spigot (plain end) of the pipe or fitting is inserted. The joint is sealed with a thermoset elastomeric gasket or lead and oakum.

CISPF are currently imported under statistical reporting number 7307.11.00.45 of the Harmonized Tariff Schedule of the United States (HTSUS). The HTSUS provisions are for convenience and customs purposes; the written description of the scope is dispositive.

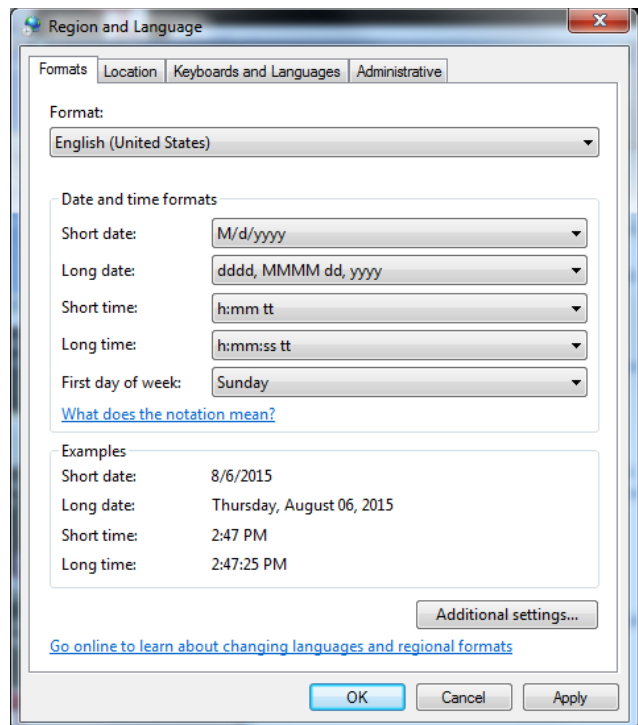
Correcting Valid number error messages.--If you are completing a Commission questionnaire in a country that uses periods (“.”) to delineate multiples of 1000 (e.g., one million would appear as \$1.000.000 instead of as \$1,000,000), you may be unable to enter in numbers greater than 999 in numeric form fields. This issues stem from your computer number formatting setting (e.g., not the MS Word document itself, but the computer from which you are opening up the document). In the United States commas (,) delineate multiples of 1000 and periods (.) delineate fractions less than one. Many EU countries use the reverse where multiples of 1000 are delineated with periods (.) and fractions less than one are delineated with commas (,). The US International Trade Commission’s questionnaires are set-up in the United States with the U.S. number formatting. When this formatting interacts with a computer set to EU number formatting, we believe this may cause this issue.

The solution to this data entry issue is to temporarily change your operating system’s number formatting to be consistent with the U.S. number formatting system while you complete the questionnaire.

When you do this the number “twelve million dollars and thirty five cents” would change from \$12.000.000,35 (Italy format) to \$12,000,000.35 (U.S. format), and then there will be no conflict with the USITC foreign producer questionnaire form. When you finish reporting the data then you can close the questionnaire and switch back to Italy settings.
