We are seeking information about gig economy worker experiences with finding tax information specific to their needs. We are collecting feedback to help the IRS improve communication and outreach to workers in the gig economy. Thank you for volunteering to participate in today's session.

Before we start, let me ask how many of you have ever participated in a focus group before? For those of you who have not, let me explain. A focus group is a research tool used to gather ideas and opinions from a group of individuals with a common characteristic or experience by means of directed discussion.

My job as a moderator is to help guide the flow of conversation, make sure everyone's comments are heard, and ensure that questions about various aspects of the topics are covered. You will see me referring to this outline during our session. The outline includes all points I need to cover with the group and helps me keep the discussion on track. It is important that we cover all of the topics. Therefore, I may at times have to break off the conversation in order to move on to another area in the guide.

When we say, "gig economy" we're referring to workers who provide services through a website or an app, also referred to as the "sharing economy" and "platform economy" (i.e. ride-sharing or performing tasks for compensation).

0-1 year (no or little experience with an entire tax season)

1-5 year(s)

5 or more years

Probe: What type of gig work?

Part 2: Tax Information

- 3) What questions do you most commonly have regarding your taxes? Probe: Where do you go to get answers to these questions?
- 4) What prompts you to seek help from a tax professional?
 Probe: What types of returns? Estimated payments? Received an IRS letter?
- 5) Describe the tax information you have received from your app-based company.

Probe: Package at sign-up or acceptance? In-app notifications or information? E-mail?

6) What do you know about IRS resources for gig economy workers?

Probe: Have you gone to the gig economy website?

- o If, "Yes": what was your experience using the site?
- o If, "No": Where do you go for tax information?
- 7) How do you file and pay your business taxes throughout the year?

[Note to moderator]: Try to find out how they pay quarterly estimated tax payments (withhold at a higher level for W-2 work, didn't realize requirement, only pay during annual filing season, etc.).

- 8) How do you keep track of your gig economy income?
- 9) How do you keep track of your gig economy expenses?

Part 3: Suggestions for Improvement

- 10) What do you wish you knew about tax requirements?
- 11) What type of assistance would you like from the IRS? Probe: Phone, mail, flyer, website?
- 12) The IRS would like to get your feedback on the document we passed out at the beginning of this session. Please take a couple minutes to read the information now.

[Note to moderator]: Provide <u>2</u> minutes for participants to review the document, then ask:

What can we do to improve the information on this flyer?

Probe: Introduction? Section 1 – Pay as you go? Section 2 – Keep good records? Section 3 – Check your tax payments? Does this flyer answer basic FAQs (Frequently Asked Questions)? Would the links to the website help you? Have you gone to the websites?

13) When you first started as a gig economy worker, what information would have helped you complete your tax responsibilities.

Probe: IRS liaison workshops? Tax information package via partnering gig companies?
