A. Justification

Explain the circumstances that make the collection of information necessary.
 Identify any legal or administrative requirements that necessitate the collection.
 Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

Section 339 of the Immigration and Nationality Act (INA) requires that the clerk of each court that administers the oath of allegiance notify U.S. Citizenship and Immigration Services (USCIS) of all persons to whom the oath of allegiance for naturalization is administered, within 30 days after the close of the month in which the oath was administered. This form provides a format for submitting a list of those persons to USCIS and provides accountability for the delivery of the certificates of naturalization as required under that section of law.

In addition, section 344 of the INA requires that USCIS reimburse the courts for their share of the expenses in connection with the naturalization process. Therefore, to properly administer the reimbursements to the courts, USCIS must have available, in a central repository, the total number of persons naturalized in the courts and the court where they were naturalized.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

The data collected on this form is used by USCIS to update its alien files and records to indicate that the aliens are now citizens; develop an audit trail on the certificates of naturalization; and to determine the payments to be made to the courts for reimbursements of their expenses in connection with the naturalization process.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

The use of this form currently provides the most efficient means for collecting and processing the required data. USCIS provides this application to the public at www.uscis.gov/n-4. This form can be downloaded, completed and saved electronically,

but cannot be e-filed at this time. USCIS is in the process of working toward electronic submission capabilities for all of its programs but has no estimate for when that capability may exist. This form is partially compliant with the Government Paperwork Elimination Act (GPEA) by allowing for accessing, completing and saving the form electronically.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

USCIS has investigated its internal processes, files, and data, as well as those of other Federal agencies that may service the same population. USCIS was not able to find any other means by which the information necessary for this process could be obtained except for the use of this form.

5. If the collection of information impacts small businesses or other small entities (Item 5 of OMB Form 83-I), describe any methods used to minimize burden.

This collection of information does not have an impact on small businesses or other small entities.

6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

If the information is not collected, USCIS will not be able to reimburse the courts for their expenses in connection with the naturalization process.

 - Requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;

This information collection is conducted in a manner consistent with the guidelines in 5 CFR 1320.5(d)(2).

On April 6, 2017 USCIS published a 60-day notice in the Federal Register at 82 FR 16847. USCIS did not receive comments after publishing that notice.

On June 28, 2017, USCIS published a 30-day notice in the Federal Register at 82 FR 29302. USCIS has not yet received comments.

9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

USCIS does not provide any payment for benefit sought.

10. Describe any assurance of confidentiality provided to respondents and the basis for

the assurance in statute, regulation or agency policy.

There is no assurance of confidentiality. The DHS Privacy Office has determined that the N-4 is privacy sensitive. The form is covered by DHS/USCIS/PIA-015(b) Computer Linked Application Information Management System (CLAIMS 4) Update November 5, 2013 and DHS-USCIS-007 Benefits Information System SORN September 29, 2008, 73 FR 56596.

A Privacy Act Statement is not required because the information is not collected directly from the individual.

^{*} The above Average Hourly Wage Rate is the May 2016 Bureau of Labor Statistics average wage for All Occupations of \$23.86 times the wage rate benefit multiplier of 1.4 (to account for benefits provided) equaling \$33.40. The selection of "All Occupations" was chosen as the expected respondents for this collection could be expected to be from any occupation.

The estimated annual cost to respondents is \$4,800. This figure is calculated by multiplying the number of responses (1920) by the estimated average cost for postage (\$2.50), which equals \$4,800.
