## Supporting Statement Declaration of the Ultimate Consignee that Articles were Exported for Temporary Scientific or Educational Purposes 1651-0036

## A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

The Declaration of the Ultimate Consignee that Articles were Exported for Temporary Scientific or Educational Purposes is used to document duty free entry under conditions when articles are temporarily exported solely for scientific or educational purposes. This declaration is provided for under 19 U.S.C. 1202, HTSUS Subheading 9801.00.40, and 19 CFR 10.67(a)(3) which requires a declaration from the ultimate consignee stating that the articles were sent from the United States solely for temporary scientific or educational use and describing the specific use to which they were put while abroad. This declaration is submitted to CBP by the importer or the agent of the importer and is used by CBP to determine whether the imported articles should be free of duty.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

This declaration is used to assist CBP personnel in determining whether the imported articles should be free of duty.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

It would not be cost effective to automate this process because CBP collects only about 17 certificates annually and we do not expect this number to increase substantially.

This information is not duplicated in any other place or any other form.

This information collection does not have an impact on small businesses or other small entities.

The consequence if this information was not collected is that it would be more difficult for importers to import items free of duty.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices: a 60-day notice published on February 8, 2017 (Volume 82, Page 9751) on which no comments were received, and a 30-day notice published on May 1, 2017 (Volume 82, Page 20369) on which no comments have been received.

## 9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

There is no offer of a monetary or material value for this information collection.

There is no PII associated with this information collection. No assurances of confidentiality are provided.

Note that CBP requests submission of about 10 percent of the certificates that are prepared. CBP only requests submission of the certificate if there is any question or concern about whether the goods are qualified for duty-free treatment. (10 percent is about 17 certificates per year)

## Public Cost

The estimated cost to the respondents is \$812.43. This is based on the estimated burden hours (27) multiplied by (x) the average loaded hourly wage rate for importers (\$30.09). CBP calculated this loaded wage rate by first multiplying the Bureau of Labor Statistics' (BLS) 2015 median hourly wage rate for Cargo and Freight Agents (\$20.13), which CBP assumes best represents the wage for importers, by the ratio of BLS' average 2015 total compensation to wages and salaries for Office and Administrative Support occupations (1.4799), the assumed occupational group for importers, to account for non-salary employee benefits.<sup>1,2</sup> CBP then adjusted this figure, which was in 2015 U.S.

dollars, to 2016 U.S. dollars by applying a 1.0 percent annual growth rate to the figure, as recommended by the U.S. Department of Transportation's value of travel time guidance.<sup>3</sup>

# 13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information.

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

# 14. Provide estimates of annualized cost to the Federal Government. Also provide a description of the method used to estimate cost, which should include quantification of hours, operational expenses (such as equipment overhead, printing, and support staff), and any other expense that would not have been incurred without this collection of information.

The estimated annual cost to the Federal Government associated with the review of these records is \$196.68. This is based on the number of responses that must be reviewed (17) multiplied by (x) the time burden to review and process each response (10 minutes or .166 hours) = 3 hours multiplied by (x) the average hourly loaded rate for other CBP employees (\$65.56)<sup>4</sup> = \$196.68.

# 15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection. There has been no change to the information collected.

# 16. For collection of information whose results will be published, outline plans for tabulation, and publication.

This information collection will not be published for statistical purposes.
