The Social Security Administration is contacting a few people who had a recent redetermination of their extra help with Medicare prescription drug plan costs. IMPORTANT INFORMATION

You do not have to give us the requested information. If you do provide the information and your subsidy level is correct, we will not have to contact you to review your eligibility for at least another year unless you report a subsequent change in your income, resources or household size. However, if the information is incorrect or you do not provide the information, we may contact you to review your eligibility within the next few months. Such review of your eligibility could result in your subsidy level increasing, decreasing, or stopping. The Social Security law that allows us to ask you questions is explained in the enclosed page, Privacy Act and the Paper Reduction Act Notice.

Your cooperation with this review will help us to ensure the process for helping Medicare beneficiaries with their prescription drug costs is providing the correct help to the correct people.

We would also like to remind you that if you (and your spouse if married and living together) have a change in your income, resources, or household size, you should report this information to Social Security.

WHAT WILL HAPPEN WHEN I CALL

PRIVACY ACT AND PAPER REDUCTION ACT NOTICE

COLLECTION AND USE OF PERSONAL NFORMATION

Section 1860 D-14 of the Social Security Act, as amended, allows us to collect this information. We will use the information you provide to determine your continued eligibility for help paying your share of the cost of a Medicare Prescription Drug Plan.

Furnishing us this information is voluntary. However, failing to provide us with all or part of the information could result in a change or termination of your subsidy.

We rarely use the information you supply for any purpose other than what we state above, however, we may use the information for the administration of our programs including sharing information:

- 1. To comply with Federal laws requiring the release of information from our records (e.g., to the Government Accountability Office and the Department of Veterans' Affairs); and.
- 2. To facilitate statistical research, audit, or investigative activities necessary to ensure the integrity and improvement of our programs (e.g., to the Bureau of the Census and to private entities under contract with us).

A complete list of when we may share your information with others, called routine uses, is available in our Privacy Act System of Records Notice 60-0321, entitled Medicare Database. Additional information about this and other system of records notices and our programs are available from our Internet website at www.socialsecurity.gov or at your local Social Security office.

We may share the information you provide to other health agencies through computer matching programs. Matching programs compare our records with records kept by other Federal, State, or local government agencies. We use the information from these programs to establish or verify a person's eligibility for federally funded or administered benefit programs and for repayment of incorrect payments or delinquent debts under these programs.
