**TITLE OF INFORMATION COLLECTION:**

Child Welfare Capacity Building Collaborative Customer Feedback for the *Child Welfare Virtual Expo: Building Capacity to Address Sex Trafficking and Normalcy*.

**PURPOSE:**

This is a request for approval by the Office of Management and Budget (OMB), under the Federal Paperwork Reduction Act of 1995, for a new data collection task to be added to the Administration for Children and Families’ already approved generic OMB clearance # 0970-0401. The proposed information collection activity is intended to allow for customer feedback regarding the *Child Welfare Virtual Expo: Building Capacity to Address Sex Trafficking and Normalcy* on July 13, 2016. This is a one-day, virtual event to build the capacity of child welfare audiences to effectively implement the Preventing Sex Trafficking and Strengthening Families Act of 2014, Public Law (P.L.) 113–183. The feedback received will allow Collaborative staff to understand the experience of customers so that they can make improvements to better serve customers and meet their information needs.

Participants will include child welfare agency and judicial staff who attend the event. The participants will be able to provide feedback about their overall experience at the end of the event.
