**Background:** The National Survey of Family Growth (NSFG) is now in the third year of 8 years of interviewing under the 2011-2019 contract. As we near the mid-point of interviewing under this contract, we have planned 2 advisory workshops to learn what mid-course enhancements are most desirable. The 1<sup>st</sup> workshop, held in November 2013, focused on NSFG data potentially relevant for monitoring the Affordable Care Act. Our main focus for this 2<sup>nd</sup> workshop is on **other changes, if any, to make to the questionnaires for 2015-2019**, but we will also discuss **sample design options** and **improvements to assist data users**.
