The link will take attendees to this customer satisfaction survey on a TTB webpage hosted by SurveyMonkey, an external website. TTB will keep the URL active for two weeks after the outreach event, at which time we will redirect the link to the event's PowerPoint presentation and compile the survey results. As TTB does not collect an email address from, or require a registration by, attendees for most of its outreach activities, sending an email or other invitation to attendees to participate is not a viable option.
