TITLE OF INFORMATION COLLECTION:

Survey of TTB Alcohol Beverage Customers Regarding Service Improvement

PURPOSE:

The results of this customer satisfaction survey will provide the Alcohol and Tobacco Tax and Trade Bureau (TTB) with high-to mid-level indicators on how well the Bureau is delivering service in accomplishing its mission. This survey will help TTB understand how our alcohol beverage industry customers would prioritize key projects to improve service delivery based on their satisfaction with existing TTB services.

DESCRIPTION OF RESPONDENTS:

All respondents are current alcohol beverage industry members who, as customers of TTB services, have provided us with an email address, as well other parties that may be associated with such customers who have submitted an email address to TTB. These customers include alcohol industry members who have filed permit, formula, and label approval applications with TTB, as well as those who have filed excise tax returns and claims, and operations reports with TTB.

We plan to compile a list of email addresses submitted to TTB and held in the following systems: GovDelivery, Permits Online, Integrated Revenue Information System (IRIS), COLAs Online, and Formulas Online. This list will predominantly contain email addresses of individuals who are alcohol beverage permit or brewer's notice holders. However, this list may also contain email addresses of individuals who are otherwise associated with permit or notice holders, such as private consultants and attorneys. TTB will examine the overall list and any duplicate email addresses will be removed.

Once the list of email addresses is perfected, we plan to send an email survey invitation to all email addresses on the list. The invitation will contain a direct link to the survey, which will be hosted by SurveyMonkey, an external website. The survey will be open for one month. Halfway through that month, a second, follow up email will be sent reminding the invitees to take the survey. At the end of the one month time period or once we reach a total of 5,000 respondents, whichever comes first, we will stop administering the survey and compile the results.
