#### A. Justification:

CBP Form 7523, *Entry and Manifest of Merchandise Free of Duty*, *Carrier's Certificate of Release*, is used by carriers and importers as a manifest for the entry of merchandise free of duty under certain conditions. CBP Form 7523 is also used by carriers to show that articles being imported are to be released to the importer or consignee, and as an inward foreign manifest for vehicles weighing less than 5 tons arriving from Canada or Mexico with merchandise conditionally free of duty. CBP uses this form to authorize the entry of such merchandise. CBP Form 7523 is authorized by 19 USC 1433, 1484 and 1498. It is provided for by 19 CFR 123.4 and 19 CFR 143.23.

The information collected on CBP Form 7523 is used by CBP to authorize the entry of merchandise that is free of duty in accordance with regulations.

CBP plans to automate this information collection by providing for electronic submission as part of the Cargo Release phase of the Automated Commercial Environment (ACE) by late 2018.

This information is not duplicated in any other place or any other form.

Public comments were solicited through two Federal Register notices including a 60-day notice published on March 29, 2017 (Volume 82, Page 15528) on which no comments were received, and a 30-day notice published on July 14, 2017 (Volume 82, Page 32561) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

#### **Public Cost**

The estimated cost to the respondents is \$247,739.88. This is based on the estimated burden hours (8,247) multiplied by (x) the average loaded hourly wage rate for importers (\$30.04). CBP calculated this loaded wage rate by first multiplying the Bureau of Labor Statistics' (BLS) 2016 median hourly wage rate for Cargo and Freight Agents (\$20.15), which CBP assumes best represents the wage for importers, by the ratio of BLS' average 2016 total compensation to wages and salaries for Office and Administrative Support occupations (1.4762), the assumed occupational group for importers, to account for non-salary employee benefits.<sup>1,2</sup> CBP then adjusted this figure, which was in 2015 U.S. dollars, to 2017 U.S. dollars by applying a 1.0 percent annual growth rate to the figure, as recommended by the U.S. Department of Transportation's value of travel time guidance.<sup>3</sup>

There are no capitalization or start-up costs associated with this collection of information. There is no recordkeeping associated with this collection of information.

The estimated annual cost to the Federal Government associated with the review of these records is \$997,294.41. This is based on the number of responses that must be reviewed (99,000) multiplied by (x) the time burden to review and process each response (.1667 hours) = 16,503.3 hours multiplied by (x) the average hourly loaded rate for other CBP employees (\$60.43)<sup>4</sup> = \$997,294.41.

There has been no increase or decrease in the estimated burden hours previously reported for this information collection. There are no changes to the information collected or to CBP Form 7523.
