


Figure 2: Measurement Specification – 1




Figure 7: Performance Measure – 3




Figure 8: Performance Measure - 4




Figure 9: Performance Measure - 5




Figure 10: Performance Measure – 6




Figure 12: Deviations from Measurement Specifications - 1




Figure 13: Deviations from Measurement Specifications – 2




Figure 14: Deviations from Measurement Specifications - 3




Figure 15: Deviations from Measurement Specifications - 4




Figure 16: Deviations from Measurement Specifications - 5




Figure 17: Deviations from Measurement Specifications - 6




Figure 19: Optional Measure Stratification - 1




Figure 20: Optional Measure Stratification - 2




Figure 21: Optional Measure Stratification - 3




Figure 22: Optional Measure Stratification - 4
