**Provider Qualitative Interviews** 

#### **PURPOSE:**

Erie County Department of Health will conduct semi-structured qualitative interviews with provider "practice champions" at each site. The semi-structured qualitative interviews will yield in-depth information on the initiation and implementation of Screening Brief Intervention and Referral to Treatment (SBIRT): 1. Factors that led each site to decide to adopt SBIRT; 2. How the sites have adapted or integrated SBIRT into their day-to-day practice (e.g., who administers the SBIRT etc.); 3. Challenges encountered in implementing SBIRT and how the practice addressed these barriers; 4. Types of best practices the providers have discovered in utilizing SBIRT in caring for pregnant and reproductive-age women that may be adopted at other locations; and 5. Suggestions for improving the program and replicating SBIRT into other practices.

#### **DESCRIPTION OF RESPONDENTS:**

Erie County Department of Health will conduct the interviews with providers (or medical directors) identified at each site as a "practice champion." Practice champions are individuals who take the lead in promoting the adoption, implementation, and dissemination of new and innovative clinical practices. In their project, the practice champions will be providers who have been utilizing SBIRT and working with their colleagues to integrate it into their practice. In addition to physicians, practice champions may also include nurses, depending upon the practice or clinic.
