The 30-minute wellness sessions provide participants with knowledge on opioid misuse, communicating with health care professionals, and general wellness education. Following is a one-hour session of trauma-sensitive yoga, which includes breathing and relaxation techniques. The purpose of the tool is to screen the participant’s thoughts, ideas, perception, opinions, and knowledge prior to starting the STEP program.
