

**Supporting Statement**  
**Application for Exportation of Articles under Special Bond**  
**1651-0004**

**A. Justification**

CBP Form 3495, *Application for Exportation of Articles Under Special Bond*, is an application for exportation of articles entered under temporary bond pursuant to 19 U.S.C. 1202, Chapter 98, subchapter XIII, Harmonized Tariff Schedule of the United States, and 19 CFR 10.38. CBP Form 3495 is used by importers to notify CBP that the importer intends to export goods that were subject to a duty exemption based on a temporary stay in this country. It also serves as a permit to export in order to satisfy the importer's obligation to export the same goods and thereby get a duty exemption. - 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

CBP Form 3495 is used by importers to notify CBP that the importer intends to export goods that were subject to a duty exemption based on a temporary stay in this country. It is used to identify the exported goods with respect to the original importation, and as a permit to export in order to satisfy the importer's obligation to export the same goods and thereby get a duty exemption.

CBP Form 3495 is automated into ACE using the Document Image System. ACE is the Database that processes Commercial Trade for the U.S. government under one single window. The Document Image System is a way to upload an attachment/scanned item or and submitting via the ACE database. This can be filled out online and printed to PDF and then submitted as an attachment directly into ACE. Nearly all of CBP Trade is processed via ACE, the goal is to have 100% processed via ACE.

The information on CBP Form 3495 is unique and is, therefore, not duplicated.

This information collection does not have an impact on small businesses or other small entities.

If this information was not collected, CBP could not determine eligibility for duty exemptions on temporary imports.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices published on May 4, 2017 (Volume 82, Page 20901) on which no comments were received, and on July 27, 2017 (Volume 82, Page 34962) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

**Public Cost**

The estimated cost to the respondents is \$60,080. This is based on the estimated burden hours (2,000) multiplied by (x) the average loaded hourly wage rate for importers (\$30.04). CBP calculated this loaded wage rate by first multiplying the Bureau of Labor Statistics’ (BLS) 2016 median hourly wage rate for Cargo and Freight Agents (\$20.15), which CBP assumes best represents the wage for importers, by the ratio of BLS’ average 2016 total compensation to wages and salaries for Office and Administrative Support occupations (1.4762), the assumed occupational group for importers, to account for non-salary employee benefits.<sup>1,2</sup> CBP then adjusted this figure, which was in 2015 U.S.

dollars, to 2017 U.S. dollars by applying a 1.0 percent annual growth rate to the figure, as recommended by the U.S. Department of Transportation's value of travel time guidance.<sup>3</sup>

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

The estimated annual cost to the Federal Government associated with the review of these records is \$77,200. This is based on the number of responses that must be reviewed (15,000) multiplied by (x) the time burden to review and process each response (.0833 hours) = 1,250 hours multiplied by (x) the average hourly loaded rate for a CBP Trade and Revenue employee (\$61.76)<sup>4</sup> = \$77,200.

**15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13.**

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection.
