^{*}The above Average Hourly Wage Rate is the May 2016 Bureau of Labor Statistics average wage for "All Occupations" of \$23.86 times the wage rate benefit multiplier of 1.4 (to account for fringe benefits) equaling \$33.40. The selection of "All Occupations" (for example) was chosen as the expected respondents for this collection could be expected to be from any occupation.

FEDERAL COST: The estimated annual cost to the Federal government is \$51,441.90

determine the cost to the federal government for collection, NPPD estimated the time burden required for government to review the collected information. The estimated annual time burden for this collection is 772 hours across the two instruments. NPPD assumes that the person handling the forms will be a GS-13 equivalent employee and have a loaded wage of \$138,600 (loaded wage equals GS-13 salary with Washington,

DC area locality pay¹ multiplied by a load factor of 1.46² to account for benefits). This equates to an hourly wage of \$66.63, which we multiply by the total hours of 772 to obtain a cost estimate of \$51,441.90. Table 3 below shows the cost breakdown by instrument.
