A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

This form is used to notify the insured that his/her endowment policy has matured, and to elicit their desired disposition of the proceeds of the policy. The information on the form is required by law, 38 USC 1917 and 1952, and 38 CFR 6.69 and 8.92.

2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

The information collected on the form is used by Department of Veterans Affairs (VA) to process the insured's request.

3. VA Form 29-5767 is available on the One-VA web site in a fillable electronic format. VBA is currently hosting this form on a secure server and does not currently have the technology in place to allow for the complete submission of this form. Validation edits are performed to assure data integrity. We are no longer looking into an electronic submission due to legal issues. Insurance requires the insured's signature.

4. Describe efforts to identify duplication. Show specifically why all similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

The information is not contained in any other VA records. Similar information is not available elsewhere.

The information does not involve any small businesses.

This form is designed for use by the insured to establish the desired disposition of the policy proceeds.

The information collection conforms with the Privacy Act of 1974 and is subject to the conditions of disclosure contained therein. The records are maintained in the system identified as 36VA00, "Veterans and Armed Forces Personnel United States Government Life Insurance Records - VA" as contained in the Privacy Act Issuances, 1993 Compilation.

11. e. The respondent population for VA Form 29-5767, is composed of individuals gathering the necessary information needed to elicit their desired disposition of the proceeds of their matured endowment policy. VA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents' costs associated with completing the information collection.

The Bureau of Labor Statistics (BLS) gathers information on full-time wage and salary workers. According to the latest available BLS data, the median weekly earnings of full-time wage and salary workers are \$954.40. Assuming a forty (40) hour work week, the mean hourly wage is \$23.86 based on the BLS wage code – "00-0000 All Occupations." This information was taken from the following website: (http://www.bls.gov/oes/current/oes_nat.htm#00-0000, May 2016).

Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$68,406.62 (2,867 burden hours x \$23.86 per hour).

13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information.

This submission does not involve record keeping costs.

This icr expired due to a transition in the VA Insurance Service that affected the process for ensuring that expiring VA Insurance icr's were submitted to OMB in a timely manner. The transition has been completed and the PRA duties have been reassigned in order avoid future VA Insurance icr's from expiring.
