### PURPOSE:

We propose to hold discussions (telephone conversations) with former grantee program staff, CNCS Senior Corps staff (e.g., state personnel, area managers), former grantees’ community partners and former Senior Corps volunteers about the Senior Corps Foster Grandparent, Senior Companion, and RSVP grantees that have relinquished their grants in 2017 or 2018. Discussion topics will include reasons they relinquished the grant, their decision-making process, the role of the state office, the transition to the new grantee, and the effects on volunteer and the community. Information from these discussions will be used in drafting an evaluation report to help Senior Corps leadership better understand the practices, experiences, and impact of this process. These discussions are part of a larger research effort to create case studies across the Senior Corps grantee caseload.
