Security Classification Guide Use Survey

Purpose.

To determine if security classification guides (SCG) are used effectively to facilitate the proper and uniform derivative classification of information. The survey is directed at personnel who derivatively classify and use or have used security classification guides. It aims to draw upon the users' experience with the guides with regard to their dissemination, the training on their use, their clarity and ease of use, classification guide content, and user knowledge.
