2018 U.S. Customs and Border Protection Trusted Traveler Programs Customer Feedback Survey

PURPOSE:

This survey will be conducted on behalf of U.S. Customs and Border Protection (CBP), an agency of the Department of Homeland Security (DHS). The purpose of the survey is to gather customer satisfaction data and feedback on the launch of the new Trusted Traveler Programs (TTP) website. In addition, the data gathered will assist CBP when launching or enhancing new public-facing websites in the future.

DESCRIPTION OF RESPONDENTS:

The *2018 U.S. Customs and Border Protection Trusted Traveler Programs Customer Feedback Survey* will be imbedded into the TTP website registration process. Survey respondents will include those who are currently going through, or have recently completed the TTP registration process, and will range in awareness of CBP, age, psychographics, demographics, and past experiences.

FEDERAL COST: The estimated annual cost to the Federal government is the cost of the SurveyMonkey (survey instrument) Premier License. This is \$1,118 annually.

Public Cost: The estimated cost to the respondents is \$3,988. This is based on the estimated burden hours (83) multiplied by (x) the average hourly wage rate for all-purpose air travelers (\$48.05). CBP calculated this wage rate by adjusting the U.S. Department of Transportation’s (DOT) recommended hourly values of travel time savings for intercity, all-purpose travel by air and high-speed rail (\$47.10 in 2015 U.S. dollars) to 2017 U.S. dollars using DOT’s recommended annual growth rate of 1.0 percent.¹
