**TITLE OF INFORMATION COLLECTION:** Community Residential Care (CRC) Program Veteran Survey

**PURPOSE:** CRC is an established VHA program wherein a community sponsor is pre-determined to qualify to serve Veterans in their facility, similar to a group home. The size of the facility varies, and is often 25-50 residents. Presently there are 3,200 such CRC Veterans served by CRC sponsors. The survey purpose is to annually gather feedback from enrolled CRC Veterans, and share the survey results with enrolled Veterans, existing sponsors, and internally with the VHA. No statistical rigor is planned, nor research, nor dispersal of information with external media sources.

**DESCRIPTION OF RESPONDENTS:** CRC Veterans are community-based Veterans who otherwise are at risk of nursing home admission, if not for the VA-approved CRC sponsors providing the needed care for them in a safe home setting.
