- 2. Received V-Impact Primary Care & Mental Health
- 3. Received V-Impact Mental Health
- 4. Received V-Impact care at a Women's Clinic V-Impact setting (any combination of Primary Care, Mental Health & Clinical Pharmacy Services)
- -Gender: We will aim to interview with at least 1-2 females out within each of the of the first 3 cohort. All of cohort 4 will be female.
- -Interviews will take place within 6 months of their latest V-Impact encounter.
