We will interview up to 50 Veterans who have VA Video Connect Visits from sleep providers (sleep specialists or respiratory therapists) at VA Puget Sound for follow up and evaluation of sleep disorders. Interviews will occur within 6 months of their VA Video Connect visit with sleep. We will aim to recruit a diverse group of Veterans including Women Veterans (at least 10% of our sample, or 5 Women).
