

## Attachment 6b - Redesigned Reinterview Questionnaire

Assurance of confidentiality – We take your privacy very seriously. All information that relates to or describes identifiable characteristics of individuals, a practice, or an establishment will be used only for statistical purposes. NCHS staff, contractors, and agents will not disclose or release responses in identifiable form without the consent of the individual or establishment in accordance with section 308(d) of the Public Health Service Act (42 U.S.C. 242m(d)) and the Confidential Information Protection and Statistical Efficiency Act of 2002 (CIPSEA, Title 5 of Public Law 107-347). All responses are dichotomous "Yes" or "No"

Read to respondent - These next questions are to make sure that the interviewer asked you the correct questions:

**Adult Annual Content**

Q1. Did the interviewer ask you questions about whether you or someone you live with has a cell phone?  
**(SACELL)**

Universe: Sample adults 18+

Q2. Did the interviewer ask whether you had difficulty with self-care such as washing all over or dressing?  
**(SASLFCARE)**

Universe: Sample adults 18+

Q3. Did the interviewer ask whether you were covered by health insurance or some other kind of health care plan?  
**(SAHINS)**

Universe: Sample adults 18+

Q4. Did the interviewer ask you about the amount of your total family income?  
**(SAINC, note: previously called FAM3)**

Universe: Sample adults 18+ (EXCEPT: Skip if child respondent completed income section AND child respondent is not the sample adult)

Q5. Did the interviewer ask whether your house has a functioning smoke detector?  
**(SMKDET)**

Universe: Sample adults 18+ (NOTE: This is trick/dummy item, we do not ask about smoke detectors)

Q6. Did the interviewer ask you whether there is a place that you usually go to when you are sick or need advice about your health?  
**(SAAUSUAL)**

Universe: Sample adults 18+

Q7. Did the interviewer ask whether you consider yourself to be gay, straight, bisexual, or something else?  
**(SAORIENT)**

Universe: Sample adults 18+

Q8. Did the interviewer ask for the last four digits of your social security number?  
**(SASOC)**

Universe: Sample adults 18+

**2018 Rotating Adult Core Content:**

Q9. Did the interviewer ask if you recently had pain?  
**(RCPAIN)**

Universe: Sample adults 18+ in 2018

Q10. Did the interviewer ask whether you recently felt nervous, anxious, or on edge?  
**(RCGAD71)**

Universe: Sample adults 18+ in 2018

**2018 Supplemental Content:**

Q11. Did the interviewer ask whether you recently worried that food would run out before you got money to buy more?

Universe: All sample adults 18+

*Read to respondent –Thank you. These next two questions are to make sure that the interviewer recorded the correct responses:*

**Adult Annual Content**

Q12. [Other than during pregnancy] Have you ever been told by a doctor or health professional that you have diabetes or sugar diabetes? (**SADIBEV1**)

Universe: We are now going to open it up to all sample adults to assess response variance. Previously we only asked of people who had responded “No”.

**Q13. Have you smoked at least 100 cigarettes in your ENTIRE LIFE? (SASMKEV)**

Universe: All sample adults 18+

*Read to respondent –Thank you. Now I am going to ask a two questions about the interview you completed on behalf of the following child in your family: ^SCNAME.*

**Child Annual Content**

Q14. Did the interviewer ask you if ^SCNAME was ever diagnosed with asthma?

Universe: All sample adults 18+ who were the proxy respondents for a sample child.

**2018 Rotating Child Core Content:**

Q15. Did the interviewer ask you how long it had been since ^SCNAME last had a dental examination or cleaning?

Universe: All sample adults 18+ who were the proxy respondents for a sample child.
