PRIVACY ACT STATEMENT

AUTHORITIES: We are authorized to collect this information by 22 U.S.C. 211a et seq.; 8 U.S.C. 1104; 26 U.S.C. 6089E; Executive Order 11295 (August 5, 1966); and 22 C.F.R. parts 50 and 51.

PURPOSE: We are requesting the information to ensure that no one has more than one U.S. passport book and one U.S. passport card at any one time, except as authorized by the U.S. Department of State, and to combat passport fraud and misuse. The collection of the Social Security number will be used to verify the identity of the person reporting the lost or stolen passport and no other purpose unless authorized by law.

ROUTINE USES: This information may be disclosed to another domestic government agency, a private contractor, a foreign government agency, or to a private person or private employer in accordance with certain approved routine uses. These routine uses include, but are not limited to, law enforcement activities, employment verification, fraud prevention, border security, counterterrorism, litigation activities, and activities that meet the Secretary of State's responsibility to protect U.S. citizens and non-citizen nationals abroad. More information on the Routine Uses for the system can be found in System of Records Notices State-05, Overseas Citizen Services Records and State-26, Passport Records.

DISCLOSURE: Providing your Social Security number and other information on this form is voluntary, but failure to provide the information on this form may, given the form's purpose of verification of your identity, result in processing delays.

Lost Or Stolen Passport Information

MINORS - If you are reporting a lost or stolen passport for a minor (persons under the age of 16), a **parent or guardian must sign and mail-in** a paper DS-64 Statement Regarding Lost or Stolen Passport.

Are you reporting your own lost or stolen passport?

However, you will be able to print a completed DS-64 Statement Regarding Lost or Stolen Passport. Next Steps

After reading and acknowledging your understanding of the instructions, you will be ready to submit your Passport form(s).

The report on the lost or stolen passport you are about to file will be placed immediately into our Consular Lost and Stolen Passport System. This system is designed to prevent the misuse of your lost or stolen U.S. passport. Anyone using your lost or stolen passport will be detained upon entry into the United States or may be denied boarding an airplane. If the passport is found at a later time, it must be reported as found and submitted for cancellation.

AS SOON AS YOU CLICK SUBMIT, THE PASSPORT BEING REPORTED IS INVALIDATED. The passport CANNOT be used for travel and CANNOT be reinstated or reactivated.

1. Submit your Lost or Stolen Report Online

By clicking "Submit" your passport will be INVALIDATED and CANNOT be used for travel or reinstated/reactivated. You will receive an acknowledgement via e-mail and have the option to print a hardcopy of the Lost or Stolen Report on the next screen.
