<b>Who must comply?</b>	Owners, operators, masters, shipyards, designers, and manufacturers (aka applicants) of certain vessels.
<b>What is this collection about?</b>	This information collection requires an applicant of a vessel to submit plans, technical information and operating manuals to the Coast Guard (CG).
<b>Where do I find the requirements for this information?</b>	Title 46 CFR Subchapter S, is available at— <a href="http://www.eCFR.gov">http://www.eCFR.gov</a> , select TITLE 46 – SHIPPING, and follow it to Subchapter S.
<b>When must information be submitted to the Coast Guard?</b>	Information must be submitted to the CG prior to construction or modification of vessel.
<b>How is the information submitted?</b>	In writing or electronically via e-mail. Information may be submitted to the CG Officer in Charge, Marine Inspection (OCMI) at the local Sector Office, or the CG Marine Safety Center (MSC). <b>What happens when complete information is received?</b>	Once all required information per Title 46 CFR Subchapter S has been provided and the CG approves it, you will be notified in writing.
