



## PRIVACY THRESHOLD ANALYSIS (PTA)

SOLAS applies to certain passenger and cargo ships that engage in international voyages. The Coast Guard issues certificates as proof of compliance with SOLAS. The form contains vessel-specific information—not PII.

The authority for the issuance of this form is 46 U.S. Code 3306, 3307, 3316 and 3703.
