

SUPPORTING STATEMENT FOR PAPERWORK REDUCTION ACT SUBMISSION

A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. The Department of Education (the Department) is submitting a request for an extension of a currently approved collection 1845-0032, the Lender's Application Process (LAP).

The Department maintains information on lenders participating in the Federal Family Education Loan program. The LAP is necessary so the Department can maintain a current database for all lenders in the program.

The legal authority for collecting this information is contained in Part B of Title IV of the Higher Education Act of 1965, as amended. A copy of this authority is attached to this collection filing as a separate document.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

The LAP will be submitted by lenders prior to beginning participation in the program. Lenders must complete and return the questionnaire in order to participate in the program. The form is also used to update current information for existing lenders.

The information is used by the Department to maintain a database of eligible and non-eligible lenders. If the information is not collected, lender payments could be delayed due to incorrect or insufficient information.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision of adopting this means of collection. The data is submitted to the Department via paper format (hard or soft copy).

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

This information is also maintained by Guaranty Agencies and/or Servicers. New lenders must complete this questionnaire in order to participate in the program and to process their Lender's Request and Special Allowance Request (ED Form 799). The ED Form 799 is cleared through the information collection 1845-0013.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden. A small entity may be (1) a small business which is deemed to be one that is independently owned and operated and that is not dominant in its field of operation; (2) a small organization that is any not-for-profit enterprise that is independently owned and operated and is not dominant in its field; or (3) a small government jurisdiction, which is a government of a city, county, town, township, school district, or special district with a population of less than 50,000.

The collection of this information does not involve small businesses.

6. Describe the consequences to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

The collection of this information is being conducted in order for the Department to update its lender participation file, to improve program monitoring and to improve service to lenders (i.e. processing of the Lender's Interest and Special Allowance Request ED Form 799). Lenders may be asked to verify the information on an annual basis. Failure to update the system will reduce the effectiveness of program monitoring.

7. Explain any special circumstances that would cause an information collection to be conducted in a manner:

- requiring respondents to report information to the agency more often than quarterly;
- requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;
- requiring respondents to submit more than an original and two copies of any document;

- requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;
- in connection with a statistical survey, that is not designed to produce valid and reliable results than can be generalized to the universe of study;
- requiring the use of a statistical data classification that has not been reviewed and approved by OMB;
- that includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or that unnecessarily impedes sharing of data with other agencies for compatible confidential use; or
- requiring respondents to submit proprietary trade secrets, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.

There are not special circumstances. The collection of information will be conducted in accordance with the guidelines in 5 CFR 1320.6.

8. Consultation with representatives of those from whom information is to be obtained or those who must compile records should occur at least once every 3 years – even if the collection of information activity is the same as in prior periods. Copies of the original LAP were sent to EduServ Technologies, Incorporated (EduServ) and the Education Loan Servicing Center (ELSC) for comments. These organizations were consulted because of the large volume of lenders they service. Since the previous approved collection, no feedback has been received.

There was a request for a 60-day public comment period published in the Federal Register on November 14, 2017. No public comments were received. This is the request for the 30-day Federal Register notice to the public for comment.

9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees with meaningful justification.

There is no payment or gift to respondents.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy. No assurance of confidentiality has been provided to respondents. The information collected here is available to the public as provided under the Privacy Act of 1974 and the Freedom of Information Act.

There are no questions of a sensitive or private nature in this information collection activity.

The total annual burden has been determined to be approximately 2 hours. The requested breakdown is as follows:

The estimated cost to the public will be approximately \$ 24.00. This was determined by multiplying the number of respondent (10) times the amount of time it takes to complete, review and submit the form (10 minutes), times an average hourly wage of \$12 per hour to prepare and review the information for accuracy.

13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information. (Do not include the cost of any hour burden shown in Items 12 and 14.)

- The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance and purchase of services component. There is no additional annual cost burden to respondents or record keepers resulting from the collection of information.

14. Provide estimates of annualized cost to the Federal government. It is estimated that the annual cost to the Federal Government of operating the computer system will be \$94.00.

This is a request for an extension of the current information collection package. There has been no change to the statutory or regulatory requirements. The total number of burden hours remains 2 hours. This is due to the unchanged number of respondents.

The Department does not plan to publish for statistical use the results of the information to be collected. Management reports, however, will be prepared.

The collection of information complies with 5 CFR 1320.9.
