HUD revises the forms every 3 years to improve them in terms of readability and to make editorial corrections, while also addressing public comments received in connection with the 60-day CFR Notice. The forms are also revised to reflect the most recently published guidance related to multifamily mortgage insurance programs (i.e. the 2016 Multifamily Accelerated Processing Guide.)*
