General Notes:

The question numbers are the variable names. Question numbers in parenthesis are for administrative purposes and will not appear on the final data set. CATI-System and other contractor-created variables are included in the survey instrument, are surrounded by brackets, and may be included on the final data set.

Response options in all UPPER CASE should not be read. Responses of Don't Know, Refused and LEGIT SKIP will be represented using codes -1, -2 and -3, respectively. Blank fields will be interpreted as inadvertent skips.

The following abbreviations are used within the instrument: LEGITIMATE SKIP is LEGIT SKIP, DK is Don't Know, REF is Refused, MTP is Made to Penetrate, and PTSD is Posttraumatic Stress Disorder.
