A.JUSTIFICATION:

1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

The Department of Veterans Affairs (VA) through its Veterans Benefits Administration (VBA) administers an integrated program of benefits and services, established by law, for veterans, service personnel, and their dependents and/or beneficiaries. Title 38 U.S.C. 5101(a) provides that a specific claim in the form provided by the Secretary must be filed in order for benefits to be paid to any individual under the laws administered by the Secretary. VA Form 21-526b is the prescribed form for supplemental disability or ancillary benefit claims.

VA Forms 21-526b is being revised to include new standardization data points; to include optical character recognition boxes. This is a non-substantive change. The contention questions in Section II of VA Form 21-526b has been revised to match other application forms to stay consistent.

Note: This control number previously contained four forms. VA Forms 21-4142, *Authorization to Disclose Information to the Department of Veterans Affairs*, and 21-4142a, *General Release for Medical Provider Information to the Department of Veterans Affairs*, have been separated from this control number. A new control number has been requested for these forms. VA Form 21-526, *Veterans Application for Compensation and/or Pension*, has been removed due to agency discretion. This form will be discontinued.

2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

VA Form 21-526b is used to gather the necessary information to determine a veteran's eligibility to apply for a supplemental claim. Without this information, determination of entitlement would not be possible. In order to expedite and streamline the claims adjudication process, VA codifies the requirement that claimants submit this form to claim supplemental benefits in its adjudication regulations.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

VA Forms 21-526b is available on the One-VA web site in a fillable electronic format. VBA is currently hosting this form on a secure server and does not currently have the technology in place to allow for the complete submission of the form. Validation edits are performed to assure data integrity. There currently is no utility process in place that will allow the data submitted on the form to be incorporated with an existing centralized legacy database.

Program reviews were conducted to identify potential areas of duplication; however, none were found to exist. There is no known Department or Agency which maintains the necessary information, nor is it available from other sources within our Department.

The collection of information does not involve small businesses or entities.

VA Form 21-526b is used to gather the necessary information to determine a veteran's eligibility to apply for a supplemental claim or ancillary benefit. Without this information, determination of entitlement would not be possible.

No payments or gifts to respondents have been made under this collection of information.

The records are maintained in the appropriate Privacy Act System of Records identified as "Compensation, Pension, Education, and Vocational Rehabilitation and Employment Records-VA (58VA21/22/28)," published at 74 FR 29275 on June 19, 2009, and last amended at 77 FR 42593 (July 19, 2012).

There are no questions of a sensitive nature.

12. Estimate of the hour burden of the collection of information:

a. Number of Respondents is estimated to total 217,178 per year.

b. Frequency of Response is one time.

c. Annual burden hours totals 54,295 hours.

d. The estimated average completion time is 15 minutes.

e. The respondent population for VA Form 21-526b is composed of individuals who are reporting the necessary information to determine a veteran's eligibility for a supplemental disability or ancillary benefit. VA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents' costs associated with completing the information collection.

The Bureau of Labor Statistics (BLS) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean weekly earnings of full-time wage and salary workers are \$954.40. Assuming a forty (40) hour work week, the mean hourly wage is \$23.86 based on the BLS wage code – "00-0000 All Occupations."

Legally, respondents may not pay a person or business for assistance in completing the information collection.
